Mapping Enforced Disappearances and the Missing

(January 27–28, 2017) Istanbul, Turkey

PROGRAM

The second thematic workshop of the **Regional Network for Historical Dialogue and Dealing** with the Past (RNHDP) in Istanbul will focus on the issue of *enforced disappearances and the missing*, in relation to the work and activities of civil society organizations (CSOs) working in the **Caucasus** and **MENA regions**. The specific objectives of the workshop are to raise awareness about the current situation of the phenomena of enforced disappearances and the missing through international cooperation among CSOs and provide a thorough map illustrating country specific contexts and manifestations surrounding these phenomena. We believe that such a mapping will be a useful instrument in both highlighting the importance of the issue in its novel and unresolved forms, and in assessing realistic venues for collaboration across disparate country settings. The workshop program is structured in three components.

- 1. **Participant Presentations**: Here we want from each participant to present basic facts and figures, and the work that they do/will be doing in relation to the phenomenon of enforced disappearances and/or the missing in their country. Each presentation is expected to answer a common set of guiding questions and are strictly limited to 15 minutes. Presentations are to serve both the objective of creating space for knowledge and experience exchange, and provide a baseline for the work of regional mapping.
- 2. **Keynote Speakers**: An equally important objective of the workshop is to introduce key concepts and practices around enforced disappearances and the missing around the region and globe. To this end, we have invited speakers with international expertise on different aspects of working with disappearances.
- 3. **Mapping**: Finally, facilitated workshop sessions will be allocated to work practically on the preparation of a regional map, which is expected to depict the context, causes, policies and other relevant information around the phenomena of disappearances and the missing for the participant countries. During the facilitated workshop, we are expected to discuss and agree on;
 - a. The method, content and structure of the map,
 - b. It's potential advocacy uses, and
 - c. A plan of action for its drafting and finalization.
